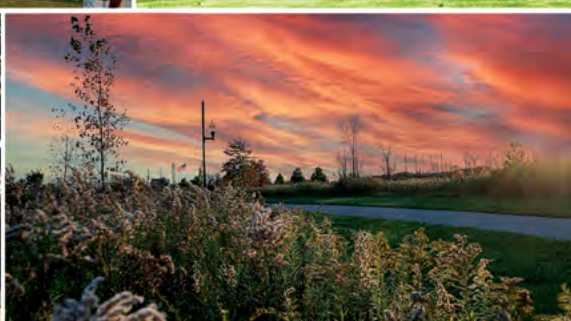
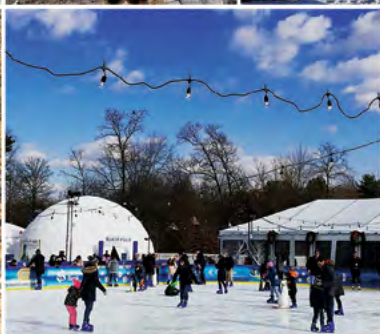

General Information

Most parks open at sunrise and close ½ hour after sunset.

Exceptions are made for facilities with lighting. Information about hours, rates, directions, schedule of events, and permits may be obtained from the Bergen County Department of Parks by visiting our website at www.co.bergen.nj.us/parks or by calling 201-336-7275.

Bergen County Golf Registration

The Bergen County Division of Golf allows golfers to play at any of our six courses for a discounted rate if they pay an annual registration fee. Registration fees for a “County Golf ID Card” are:

- Adult Resident – \$60
- Senior Resident – \$45
- Junior Resident – \$45
- Non-Resident – \$100
- Active Military/Military Veterans – \$45

New registrations can be done in-person at any golf course. The application for the “County Golf ID Card” can be found at www.golfbergencounty.com. For questions, please call the Division of Golf at 201-336-7259.

Permitting

Permits are required for many activities in the County Parks System. Examples include:

- Hosting a picnic
- Reserving an athletic field
- Holding a special event
- Using the archery range
- Professional photography
- Camping
- Utilizing the crew boat launches in Overpeck County Park and Riverside County Park–South
- Flying model planes

Filming

A Bergen County film permit is required to film in any county park. Permit fees vary depending on length of shoot, crew size, and number of vehicles. Please contact the Bergen County Office of Film & Television for additional information at www.co.bergen.nj.us/film-tv-office or by calling 201-336-6972.

Safety Precautions

Park-goers can rest assured that Bergen County Parks are routinely patrolled by security officers and animal control officers. For life threatening emergencies, please dial 911. If you witness unlawful or unsafe activities, please call the Bergen County Public Safety Operations Center at **201-785-8500**.

Do not feed or approach wildlife or unfamiliar domesticated animals like dogs or cats. If you see an animal behaving strangely or aggressively, calmly move to a safe location and alert park staff. If you are scratched or bitten, alert park staff and contact a healthcare provider immediately.

Avoid insect borne diseases like West Nile and Chikungunya by wearing insect repellent and avoid damp or boggy areas. When hiking and camping, wear long pants, long socks, and long sleeves as a precaution against deer ticks which can carry Lyme disease. Check pets and areas of exposed skin regularly for ticks.

RECREATIONAL ACTIVITIES

No matter the season, there are a myriad of active and passive recreational opportunities for everyone to enjoy throughout the parks system.



Archery

Try your hand at one of the oldest sports in the world, dating back to 2800 BCE, at the Campgaw Mountain Archery Range. Free and open daily to anyone with a Bergen County Archery Permit, Campgaw Mountain Archery Range is the perfect place for both beginners and experts looking to hone their skills. Bocce

Riverside County Park–North is home to bocce courts that are open to the public on a first come, first served basis.



Camping

Bergen County offers three unique locations to go camping— Campgaw Mountain Reservation, Ramapo Valley County Reservation, and Camp Glen Grey. Campgaw Mountain Reservation and Ramapo Valley County Reservation are ideal locations to camp for families and small groups. To camp at either location, you must obtain a permit from the Bergen County Parks Permit Portal: www.co.bergen.nj.us/permits. The permit costs \$10 per night, per site, and each site allows up to six people.

Camp Glen Gray is an independently managed camping destination located on Bergen County Parks land in Mahwah.

An overnight, weekend-only (Friday night to Sunday morning) facility, reservations for Camp Glen Gray can be made online at www.glengray.org or by phone at **201-327-7234**. Campsites and cabins are both available to rent. For pricing and more information, please visit: www.glengray.org.



Cricket

Once one of the most popular sports in the United States until baseball's dominance emerged after the Civil War era, cricket is seeing a resurgence in many communities across New Jersey, especially here in Bergen County. Leagues and groups may utilize the following fields to play this exciting **11 vs. 11** sport:

McFaul Environmental Center, and Darlington County Park during swim season) as long as they are kept on a 6ft leash. Currently, there are six Off-the-Leash Dog Parks located in every corner of Bergen County. We encourage you to explore them all!

Fishing

Catch-and-release fishing is permitted at designated ponds, lakes, and streams in the Bergen County Parks System. The following parks have at least one site for fishing:

- Campgaw Mountain Reservation
- Camp Glen Gray
- Dahnert's Lake County Park
- Darlington County Park
- Overpeck County Park
- Pascack Brook County Park
- Ramapo Valley County Reservation
- Saddle River County Park – Wild Duck Pond Area, Glen Rock Area, & Otto C. Pehle Area
- Samuel Nelkin County Park
- Wood Dale County Park

The State of New Jersey requires anyone age 16 and older to have a valid license to fish at freshwater locations with a handline or rod and line. Fishing licenses must be worn in a conspicuous place on the outer clothing while engaged in fishing and must be exhibited to law enforcement, Bergen County security, and/or parks personnel on request.

Golf

With six beautiful county golf courses that vary in difficulty and character, Bergen County is the ideal place to catch a round for novices and experts alike. For more information, see page 91.

Group Picnics

A Picnic Permit is required for group picnics of 10 or more people in any county park. Picnic fees vary based on the number of attendees, county residency status, and the type of area requested.

Picnic Permits can be booked up to 6 months in advance. The Picnic Permit Application can be found on the Bergen County Parks Permit Portal: www.co.bergen.nj.us/permits.

Hiking

Hiking trails can be found at Ramapo Valley County Reservation and Campgaw Mountain Reservation. To view trail maps, please visit: www.co.bergen.nj.us/parks

Hiking essentials: Comfortable hiking shoes or boots, dress for the weather (e.g. jacket/rain gear, hat, etc.), trail map, flashlight or headlamp, food, water, first aid kit, sun protection, insect repellent, and a whistle to alert rangers to your location if you become lost or disoriented.

Ice Skating

In the winter, grab your skates and head over to Van Saun County Park to enjoy the Rink at Bergen County's Winter Wonderland. Open from late November to the end of February, visitors are welcome to skate at Bergen County's outdoor ice rink!

Horseback Riding

Interested in learning how to ride or in honing your equestrian skills? The Bergen County Parks System is home to both the Bergen Equestrian Center and the Saddle Ridge Riding Center. Model Planes

Flying model airplanes is permitted in the Aerodrome located in Overpeck County Park, Henry Hoebel Area–North. Only electric planes are allowed. Pilots must have a valid Academy of Model Aeronautics license and a Model Plane permit from the Bergen County Parks Department. To obtain a permit, please visit: www.co.bergen.nj.us/permits.



Pickleball

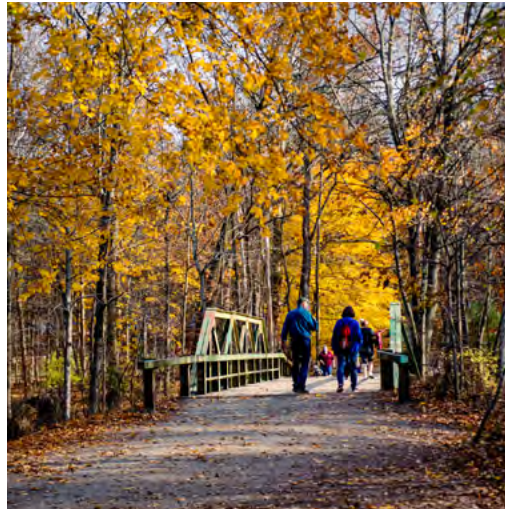

Rowing and Kayaking

The Bergen County Parks System has designated water access locations for rowing and kayaking.

The Hackensack Riverkeeper (see page 121) operates seasonal rowing at both the Van Buskirk Island County Park Paddle Center and the Overpeck County Park Paddle Center. In addition, the Henry Hoebel Area—South of Overpeck County Park and Riverside County Park—South both feature a designated rowing launch for competitive crew teams. Skiing/Snowboarding/ Tubing

Bergen County is home to a ski slope at Campgaw Mountain Reservation which offers five trails at a 276-foot drop and a tubing run (see page 128). Better on flat terrain? Ramapo Valley County Reservation is a popular spot for snowshoeing or cross-country skiing.

Swimming and Water Recreation

During the summer season, swimming is offered at The Lakes at Darlington County Park. Patrons can cool down by swimming at the lower lake or braving the Wibit Splash Zone water obstacle course at the upper lake.

Winter Activities

After any given snowfall, several Bergen County Parks become sledding and snowshoeing hotspots.

Bergen County's Winter Wonderland at Van Saun County Park attracts over 30,000 visitors each year and promotes year-round access to the Bergen County Parks System. It features outdoor skating, games, a beer and wine garden, ice bumper cars, and live entertainment. Winter Wonderland has become a cherished holiday tradition and is New Jersey's premier destination for holiday family fun!



Artesian Fields County Park

Boulevard and Gilbert Street, Elmwood Park

This 44-acre, hidden gem in Elmwood Park features nature walking paths through mostly untouched forest, as well as a softball field and a baseball field. Off the beaten path, this County Park is a natural oasis in the middle of suburbia.



Borg's Woods County Park

Fairmont Avenue, Hackensack

This 15-acre nature preserve with woodlands and wetlands is located within our county seat of Hackensack. An old growth remnant of deciduous forest, the preserve features trees that are estimated to be over 200 years old. Trailheads can be found at the end of Byrne Street and at the end of Allen Street on Fairmount Avenue. Limited street parking is available. Visitors should note the trail is short, encompassing 1/5 of a mile (1056ft).

Belmont Hill County Park

79 Botany Street, Garfield

Belmont Hill County Park is a small 10-acre park atop Belmont Hill in Garfield with a sprawling lawn and views of Manhattan.



Dahnert's Lake County Park

**411 Midland Avenue,
Garfield**

Dahnert's Lake County Park provides 10 acres of recreation in a busy urban center. Amenities include a playground, two gazebos, a half-mile long pedestrian pathway, fishing, and a roller hockey rink. Limited street parking is available.



Hackensack River County Park & Pathway

**Hackensack Avenue,
Hackensack**

Located along a 5-mile stretch of the Hackensack River, the Hackensack River Pathway provides access at several points along the trail. While not a fully connected pathway, each portion allows for a quiet getaway from the otherwise busy region.

People seeking a break from the busy workday, bird watchers, and those who are just out for a different experience can enjoy a walk along the river and marvel at the variety of wildlife that lives on the waterfront. Entrances to the park are located periodically along the trail.

Within its 1,194 acres of forest, the sprawling Campgaw Mountain Reservation offers something for everyone throughout the year.

Come visit Campgaw Mountain Reservation during the summer, spring, and fall to hike 10 miles of marked trails, practice your aim at the archery range, spend a night in the great outdoors at the campgrounds, have a relaxing picnic in the woods, or play a round of disc golf in the only public course in Bergen County! Camp Glen Grey

200 Midvale Mountain Road, Mahwah

Deep in the heart of the Ramapo Valley, this rustic former Scout camp was established in 1917. When the County acquired the property in 2002, Glen Gray was one of the oldest Scout camps in operation in the country. Today, the camp is an outpost in the Ramapo Mountains that can accommodate groups of all sizes and needs.

In addition to hiking trails that connect to the greater regional trail network, the camp's Lake Vreeland is equipped with boat rentals and ample fishing opportunities along its shore. Camping accommodations include cabins, lean-tos, and tent sites.

In the winter, wood stoves in the cabins will keep you warm. Additionally, many of the cabins also have electricity.

In keeping with the camp's rustic mode, bathroom facilities at the campsites consist of latrines. Flush toilets are available in warm weather and located off the parking lot.

Your family or organization can play sports and games at Mary Post Field or enjoy the campfire ring and amphitheater for an outdoor gathering or event. A dining hall (with a kitchen) may be used for indoor events and meals.

Camp Glen Gray is located near several points of interest, making it the perfect base camp for exploring the region. While feeling secluded from the hustle and bustle of modern life, the camp is never too far from modern amenities if one finds themselves in need of something.





DARLINGTON COUNTY PARK

Resting in the foothills of the Ramapo Mountains, the 127-acre Darlington County Park offers a unique afternoon getaway.

THE LAKES AT DARLINGTON

Tucked away at the base of the Ramapo Mountains, Darlington County Park is conveniently located between major highways, making it the ideal summer destination for a beach trip close to home. The park features three lakes: the first lake is designated for fishing, the second lake, with its white sand beach, provides the perfect opportunity to swim and relax, and the third lake is home to the Wibit Splash Zone water obstacle course.

The Lakes at Darlington are open for swimming every Memorial Day Weekend through Labor Day Weekend, 10AM to 6PM, weather permitting. Fishing is permitted year-round for those with a valid NJ Fishing License, except when the pond is frozen.










The park also includes paved and unpaved pedestrian pathways, wooded picnic areas, open lawns, basketball and handball courts, and plenty of bird and wildlife observation areas throughout.

The Parks Department charges an entrance fee during swimming season. Discounts are available to Bergen County residents.

THE LAKES AT DARLINGTON

Darlington County Park now features the Wibit Splash Zone, an inflatable water obstacle course comprised of a puzzle of configurations including ramps, slides, rope climbs, and a trampoline. This ticketed amenity operates during the swim season, weather permitting. The Wibit Splash Zone has two separate courses, one for adults 48 inches or taller and a second course for children between 39 and 48 inches in height. Bergen County residents enjoy discounted pricing on tickets.

The McFaul Environmental Center was founded in 1967 and named after former Bergen County Parks Executive Director, James A. McFaul, who was instrumental in the development of the site. Purchased in 1962, the property was originally an 81-acre pig farm. It began its transformation into a wildlife sanctuary in 1966 when the 2.5-acre waterfowl pond was excavated.

Today, the park includes bird shelters, an auditorium, natural history displays, a browsing library, a memorial gazebo, natural science aquariums, and monthly art displays. Visitors can enjoy the grounds by walking on a $\frac{2}{3}$ mile gravel-surfaced woodland nature trail. There is also paved access to a 300ft boardwalk that takes visitors along the edge of the pond to a two-story observation platform. The observatory overlooks a butterfly/hummingbird garden and a pond which supports various species of waterfowl.

For schools and other groups, a large selection of nature education programs and workshops are conducted weekdays throughout the year.

The Environmental Center also hosts popular seasonal programs, including the acclaimed pancake breakfast and maple sugaring demonstration, apple cidering, the haunted hideaway of horrors, halloween hayrides, and the gingerbread creations contest.

The Environmental Center is open daily. The park opens at 8AM on Weekdays and 8:30AM on Weekends and Holidays. Park closing times change with the seasons. The earliest the park closes in the winter is 5:15PM and the latest in the summer is 6:45PM. Please call the Environmental Center for an up-to-date schedule at **201-291-5571**.

The Museum is open 8:30am-4:45pm on Weekdays and is open 10am-4:45pm on Weekends. It is closed on holidays.



Regulations

All groups of 10 or more must have a Park Use Permit. Weddings and photography are allowed at the Environmental Center by permit only. The park is carry-in/carry-out, so trash must be removed or placed in dumpsters located in each parking area.

The park is a wildlife sanctuary. All plants and animals are protected by law.

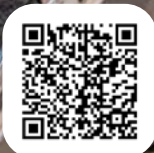




OVERPECK COUNTY PARK

Overpeck County Park



Overpeck County Park, named for Overpeck Creek which flows through the park, spans four Bergen County municipalities—Leonía, Palisades Park, Ridgefield Park, and Teaneck.

With nearly 800 acres, Overpeck County Park is Bergen County's premier recreational venue. Visitors can enjoy over six miles of walking, biking, and nature paths, various sports courts, playgrounds, picnic areas, a pollinator garden, and catch-and-release fishing.



The park also features the Bergen County World Trade Center Memorial, a grass amphitheater for special events, athletic fields (by permit), a crew boat launch (by permit), the Overpeck Aerodrome (by permit), Overpeck Paddle Center with kayaks and canoes to rent, the Bergen Equestrian Center, and Field Station: Dinosaurs.

Overpeck County Park is a place where visitors can relax, play, enjoy time with family and friends, and come together as a community.



Overpeck County Park is divided into five open sections:

- **Henry Hoebel Area–North**, Leonía
- **Henry Hoebel Area–South**, Leonía
- **Ridgefield Park Area**, Ridgefield Park
- **Overpeck Sportsplex**, Palisades Park
- **Teaneck Creek Area**, Teaneck

Henry Hoebel Area–North

40 Fort Lee Road, Leonia



The Henry Hoebel Area–North, located in Leonia, boasts a wide variety of amenities including sports courts, cricket pitches, a fitness station, a football field, a track, an off-leash dog park area, and the Bergen County World Trade Center Memorial.

There is a double-looped paved pathway that is extremely popular with joggers, dog walkers, and more! This section is also home to the Bergen County Aerodrome, where flying model electric airplanes is allowed by permit.





World Trade Center Memorial

The Henry Hoebel Area–North is home to the Bergen County World Trade Center Memorial, which honors county residents killed during the terrorist attacks of September 11, 2001.

Bergen County holds a ceremony at the memorial on September 11th every year to memorialize those lost on that tragic day.



Field Station: Dinosaurs

This section of Overpeck County Park is also home to Bergen County recreational partner and educational attraction Field Station: Dinosaurs (see page 117). The Henry Hoebel Area–South in Leonia is home to a pollinator garden, a crew boat launch (by permit), and the Bergen Equestrian Center.

The Bergen Equestrian Center (see page 116), established in 1974, is a multi-service horse facility on 22 acres of landscaped grounds, providing a home for over 75 horses. Amenities include three outdoor riding rings, two indoor riding rings, air-conditioned tack rooms, and a heated lounge with a panoramic view of the main indoor arena for an optimum year-round experience.

Programs include children’s camp, group and individual riding lessons, corporate team building, and “A Stable Life; a non-riding equine

treatment program, guided by qualified professions, focused on prevention, education, healing, and assisted recovery for those dealing with life challenges like anxiety, isolation, loss, addiction, or symptoms of PTSD.



Ridgefield Park Area

199 Challenger Road, Ridgefield Park



The Ridgefield Park Area of Overpeck County Park opened in 2010 and quickly became the most utilized section of the park.

It features baseball, softball, and soccer fields, tennis and pickleball courts, a playground, a large grass amphitheater, clean and convenient restrooms, a boat launch, a Paddling Center with kayaks and canoes to rent operated by the Hackensack Riverkeeper (see page 121), catch-and-release fishing, and miles of walking path.



Overpeck County Park

This section of Overpeck County Park also features complimentary electric vehicle charging stations thanks to a public-private partnership between the County of Bergen and Shell Charging.

The Amphitheater at Overpeck County Park is the ideal destination for community events. The Ridgefield Park Area hosts several large County events, benefit walks, cultural festivals, concerts, and more every year. Additionally, it is the site of Bergen County's annual summer concert series and 4th of July celebration.



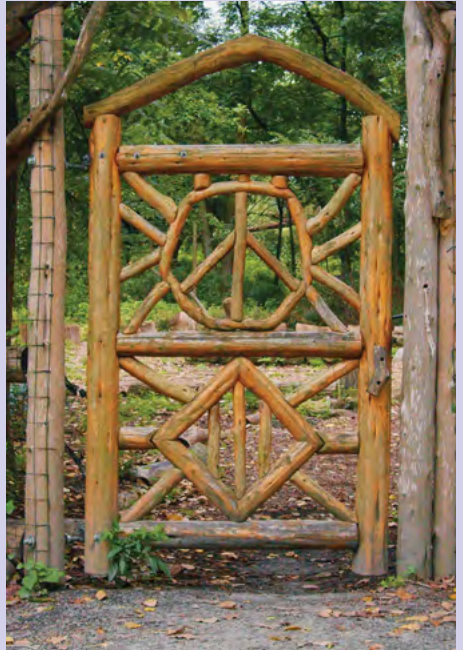

In 2020, the Parks Department began a 20-acre wetland-restoration effort to restore the native ecosystem of the Teaneck Creek section of Overpeck County Park.

The project included the removal of invasive plants species, the reintroduction of tens of thousands of native plants, and innovative natural infrastructure, including the first regenerative stormwater conveyance system in New Jersey. The project's first phase was successfully completed in 2022. This was the County's first habitat restoration project, righting years of environmental injustices that occurred at Overpeck County Park and its surrounding areas.



Overpeck County Park

The park has already witnessed a remarkable return of wildlife. Over the next few years, as the native plants continue to flourish, the wildlife population will continue to grow and thrive.

This section of Overpeck County Park is managed by the Teaneck Creek Conservancy, a non-profit organization dedicated to the protection of the park. For more information about the Teaneck Creek Conservancy, see page 129.

With 45 picnic tables and two pavilions, Pascack Brook County Park is the ideal location for both small and large gatherings. For additional information about fishing, see page 13.

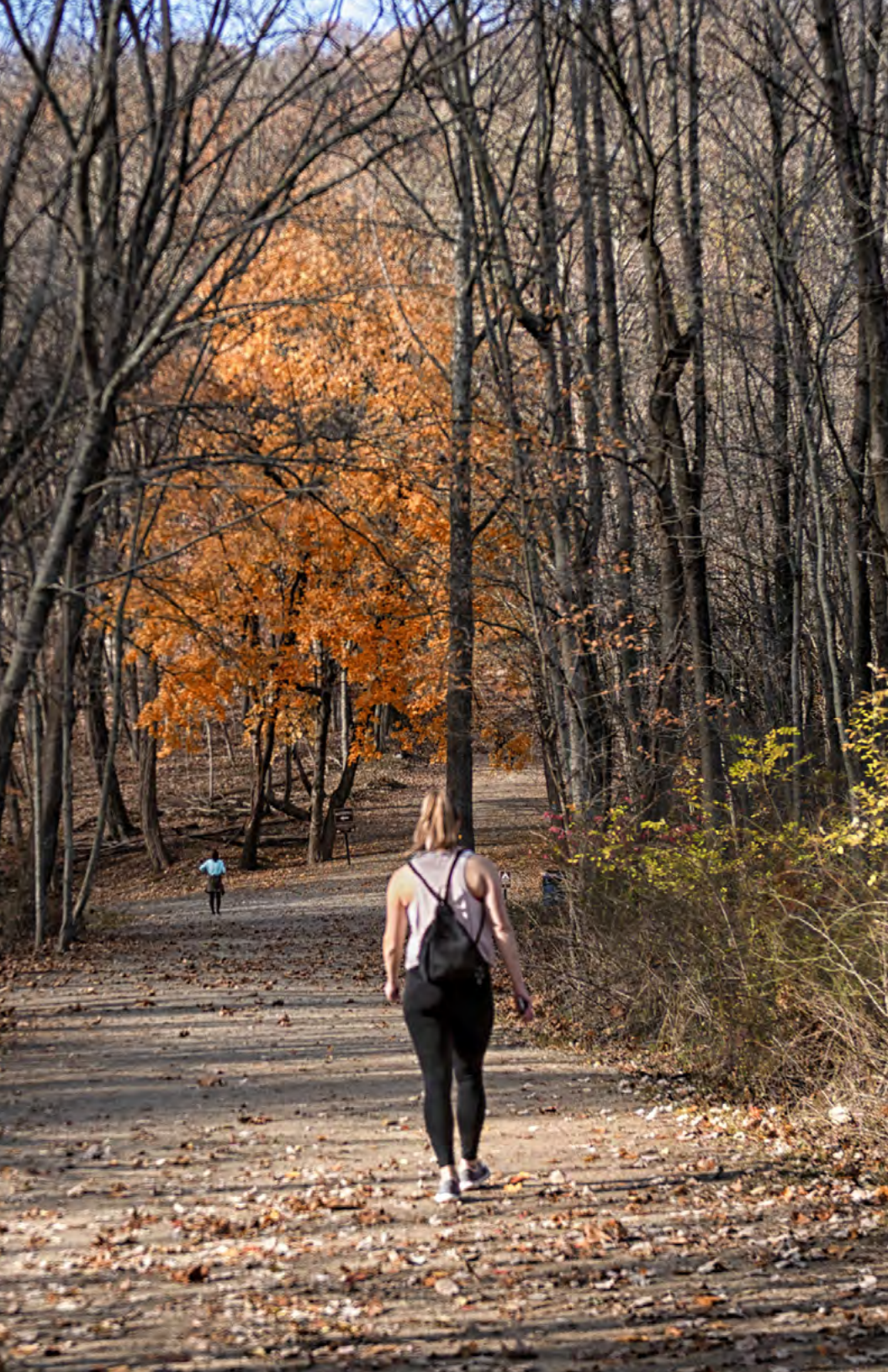




RAMAPO VALLEY COUNTY RESERVATION

**608 Ramapo Valley Road (Route 202), Mahwah
Main Trail-Head Access and Parking Lot**

Nestled against the eastern edge of the scenic New Jersey Highlands Region, Ramapo Valley County Reservation boasts the title of Bergen County's largest park. Encompassing over 3,200 acres just 30 miles from Manhattan, the park offers a haven for outdoor enthusiasts with its extensive trails, camping options, and diverse activities.



Ramapo Valley County Reservation

Located in the ecologically diverse Highlands Region, Ramapo Valley County Reservation is Bergen County's largest park. With funds from the County, the New Jersey Green Acres Program, and generous donors, Camp Glen Gray, and the former scout camps Camp Tamarack and Camp Todd were acquired, resulting in 3,268 acres of preserved parkland just 30 miles from Manhattan.

There is canoe & kayak access to the Ramapo River and several ponds to enjoy a calm day of fishing. In the winter, the Ramapo Valley County Reservation is a cross-country skiing destination, as well.

Hiking

The reservation consists of 22 miles of maintained gravel walking trails. Visitors can hike and camp along the reservation's trails that connect to Ringwood State Park, Skylands Manor, and Hawk Rock.

Check out the Vista Loop, a hike you can complete in a day. It explores several vistas, including a waterfall and a panoramic view of New York City.

Riding Center

The Ramapo Valley County Reservation also features the Saddle Ridge Riding Center, a county-owned facility privately operated by Saddle Ridge Riding Center, Inc., offering a full-service equestrian facility set on over 28 acres of mountains, fields, and trails. See page 127.

Camping

Ramapo Valley County Reservation has nine campsites, available by permit. Permits are issued from 3pm on the date selected until 10am the following day. The permit costs \$10 per night, per site, and each site allows up to six people. Fire permits are required for each campsite. For camping details, see page 12.

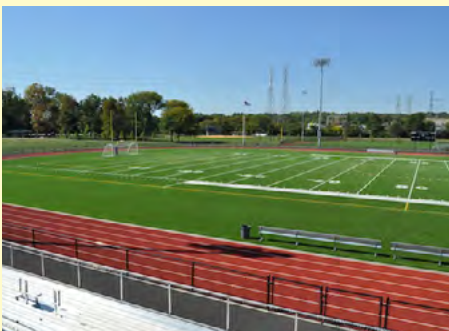
Riverside County Park–South

Riverside County Park–South is comprised of over 51 acres of parkland. It features the new state-of-the-art Bergen County Rowing Center (see page 52), the brand-new community performance space, The Stage at Riverside County Park–South, one baseball field, two softball fields, tennis and pickleball courts (with lighting), and a multi-use stadium for track & field, soccer, and football. This section of Riverside County Park also includes a picnic pavilion, a boating dock with storage for rowing in the Passaic River, and a nearly one-mile pedestrian walking path.

Riverside County Park–South will soon include a completely inclusive playground that features safety surfaces, shading, fencing, and a quiet play area for residents of all abilities. These features will be supported by improved lighting, safer walking routes within the park, new pedestrian access points, and closer parking facilities.



Bergen County Rowing Center

797 Riverside Avenue, Lyndhurst

The Bergen County Rowing Center, located in Riverside County Park–South, is operated by the Passaic River Rowing Association (PRRA) (see page 125).

The Passaic River, a wide tidal river in northern New Jersey, offers a 12-mile stretch south to Newark and north to Garfield. This new facility provides unprecedented access to this once neglected waterway and includes a 120ft-long dock with public access during park hours for kayaking and canoeing. First opened in September 2022, this state-of-the-art facility has already hosted several high school and collegiate regattas.

Saddle River County Park



Saddle River County Park is one of the oldest assets in the Bergen County Parks System with portions of the park initially opening to the public in 1952.

This linear park features seven distinct areas and a historic landmark that is connected by over ten miles of pathways. Saddle River County Park includes a six-mile bike and pedestrian path that runs through Ridgewood, Glen Rock, Fair Lawn, Paramus, Saddle Brook, and Rochelle Park. The path parallels the Saddle River and Ho-Ho-Kus Brook traversing past the 125-year-old historic county site, the Easton Tower (see page 85) and a scenic waterfall at Dunkerhook Park.

- Wild Duck Pond Area
- Fair Lawn Area
- Glen Rock Area
- Dunkerhook Area
- Otto C. Pehle Area
- Rochelle Park Area



Wild Duck Pond Area

1133 East Ridgewood Avenue, Ridgewood



The Wild Duck Pond Area is the most northern section of Saddle River County Park. Located in Ridgewood, the Wild Duck Pond Area can be reached from the south via the bike and pedestrian path along an invigorating 2-mile stretch that hugs the river. Park amenities include picnic areas, a pavilion for large groups, a playground, and a dog park. For generations, this suburban refuge has offered visitors passive and active recreation with pond activities including model boating and fishing with the proper permits.

Restoration

In 2022, the Tedesco administration completed a major \$1.7 million ecological restoration of the Wild Duck Pond which included replacing the degrading pond liner and installing three new LED multi-colored fountains and aerators.

These additions assist with water circulation and maintain a healthy level of oxygen in the pond to support wildlife and reduce and manage algae growth. Following recommendations from the 2019 Bergen County Parks Master Plan, the Wild Duck Pond also saw the implementation of stormwater best management practices through the construction of stormwater treatment wetlands, fringe wetlands within the pond, and the utilization of native plants appropriate for this freshwater wetland system.



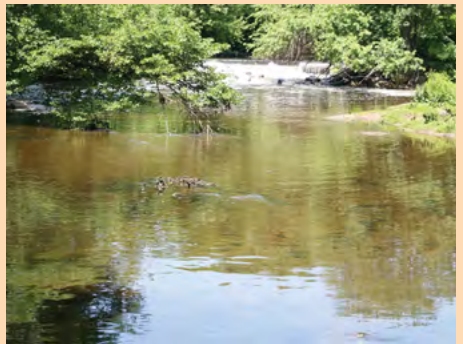
Dunkerhook Area

Located in the northern region of Saddle River County Park, the Dunkerhook Area has a playground and numerous picnic areas.

There is an area on the Saddle River reserved for fishing and a lovely waterfall for nature lovers to enjoy. The bike and pedestrian path forks just beyond the falls, which leads to either the Wild Duck Pond Area in Ridgewood or the Glen Rock Area.

This area of the park includes a playground, two tennis courts, a picnic area, and pavilion area for large groups, available by permits. Named after a former Bergen County Parks Commissioner, the Otto C. Pehle Area continues along the mixed-use path, including a $\frac{3}{4}$ mile loop around the pond. The park also features a popular playground. In addition, there is a softball field and a pavilion, both available for use with proper permits. The Otto C. Pehle Area is also home to the Yitzhak Rabin Tree Grove.



Rochelle Park Area

Railroad Avenue, Rochelle Park



The Rochelle Park Area is home to newly renovated sports courts that include tennis, pickleball, and basketball courts. Additionally, the Rochelle Park Area includes a playground, a softball field, and a pavilion for group gatherings, available by permit. Further south along the pedestrian and bike path, in Saddle Brook, is Vander Sande baseball field. The mixed-use path in this area begins at Railroad Avenue and winds along the river for approximately one mile.





Samuel Nelkin County Park

1 Parkview Drive, Wallington



Tucked against a hillside, Samuel Nelkin County Park offers 17 acres of activities for visitors including a playground, a dog park, fishing areas, pickleball courts, and a newly resurfaced tennis court. There is also a baseball/softball field and a covered pavillion available by permit.


Formerly known as Wallington County Park, the space was renamed in 1979 in honor of former Wallington Mayor and NJ Transit President, Samuel Nelkin, who deeded the 17-acre property to the Bergen County Parks Commission in 1954.



Van Buskirk Island County Park

Van Buskirk Island County Park is a man-made island in the middle of the Hackensack River, formed to support industry in the area. The Hackensack Water Company transformed the island in the 1880s into one of the earliest water filtration plants in the nation. Bergen County acquired the property in the 1990s. Today, it offers prime birdwatching opportunities and is home to the Van Buskirk Island County Park Paddle Center, allowing visitors to interact with the tree-lined Hackensack River.

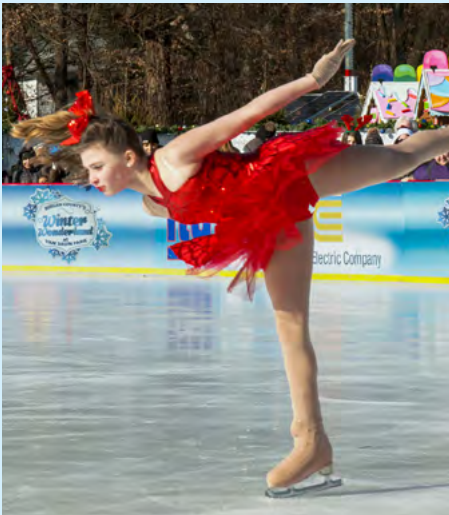

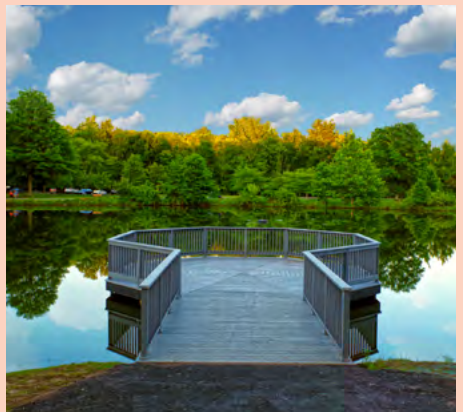

Bergen County Zoo



First opened as a nursery rhyme-themed children's zoo in 1960, the Bergen County Zoo has been the source of fond memories for over 60 years as one of New Jersey's most beloved community zoos.

The Bergen County Zoo has over 40 different species of animals in its collection. The Zoo works with various endangered species and participates in numerous conservation projects.

Highlights over the years include the hatching of an Andean Condor chick and its subsequent release in the Andes Mountains of Columbia as part of an international conservation program. Additionally, numerous rare and endangered species are part of the collection as part of multi-institutional captive breeding programs.



Most recently, the Zoo has partnered with the Red Wolf SAFE program to help in the repopulation of this endangered species in the wild. In 2021, two males were brought to the Zoo with the assistance of the Wolf Conservation Center.





Education Opportunities

The Bergen County Zoo offers a wide variety of educational programs throughout the year. Programs are available to public, private, and home school groups; scouts, recreation groups, and playgroups; local nursing homes and public libraries; and individuals and families.

School Groups

From September through June, schools and groups can reserve programs offered either on-site in the Zoo's Education/Discovery Center classroom or off-site at their own facility. There are many programs to choose from. Playgroups, home school groups, and other organized groups may also schedule an education program throughout the year. All of these programs are hands-on, and include a live animal demonstration. To learn more about current programming, call the Education Department or visit the Zoo website.

Bergen County Libraries

Zoo educators also present programs for children at public libraries throughout Bergen County. These programs also include a live animal guest. If you have not seen a zoo program at your library lately, ask your librarian to give us a call!



Children & Family Programs

During the summer, the Bergen County Zoo offers Zoo Camp for children ages 3–17 years old. Children 3–12 years old tour different parts of the zoo, observe the animals, play games, and make crafts. They also enjoy an up-close animal encounter each day. Children 13–17 years old, called “Junior Zookeepers,” will explore different aspects of a career in zookeeping. Junior Zookeepers gain hands-on experience as they learn about our animals, prepare their diets, and clean their enclosures.

Zoo Babies and Zoo Kids are our newest child–adult programs. Each series lasts several weeks and encourages our youngest visitors (1–4 years old) to spend quality time with their favorite adult, learning about the zoo’s animals through songs, movement, activities, and special zoo “safaris.”

Additional animal programs are offered during school breaks and occasional weekends throughout the year.

These programs range from 1–3 hours in length, and may be offered on weekdays, weekends, and evenings. Some are for children only and some are for the entire family.

Zoo Birthday Parties are available for children 5 years old and older; maximum of 20 children. Parties last 90 minutes and include a live animal demonstration.



Volunteers

Volunteers are an important part of our Education Department, with opportunities for teenagers and adults, alike.

Junior Docents, available to high school students, participate in conservation efforts, learn about wildlife, and hone their public speaking skills while educating visitors within the zoo. The regular Docent program, available to those 18 and up, empowers volunteers to serve as educators and interpreters both inside the zoo and out in the community, assisting with a variety of educational programs all year long. 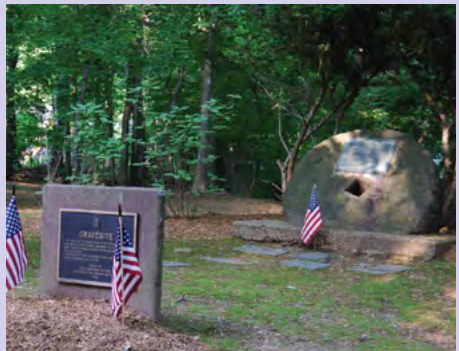

On September 27, 1778, during America's Revolutionary War, American Forces under Lt. Colonel George Baylor's command were dispatched to watch the bridge over the Hackensack River at the intersection of what is now Rivervale Road and Old Tappan Road. Shortly after midnight on September 28, British forces launched a surprise attack on the 3rd Continental Light Dragoons in what is known today as the Baylor Massacre. The attacking British forces were led by General Charles "No-Flint" Grey. His men used their muskets and bayonets to club and stab the sleeping dragoons. The next day, a detachment of the Bergen County Militia was dispatched to this area to look for survivors.

Finding six dead at the bridge, and fearing the possible return of British troops, they hurriedly buried the men in abandoned leather tanning vats located next to the river. In 1967, when the property was threatened with development, the County was contacted and worked to acquire the site.

A subsequent archaeological dig located six sets of remains. In 1974, the patriots' remains were reinterred in the park and the original millstone was donated to serve as their gravestone. In 2003, new historic interpretive signs, sitting walls, and accessible pathways were dedicated.

The Camp Merritt Memorial Monument marks the center of an important World War I embarkation camp. More than one million U.S. soldiers passed through the camp on their way to and from the battlefields of Europe. Camp Merritt covered an area of 770 acres that included Cresskill, Demarest, Dumont, Haworth, and Tenafly. Strategically built between two major rail lines, the camp had a capacity of 42,000 men and contained 1,300 buildings of all uses.

In August 1919, the Bergen County Board of Commissioners purchased land for the monument. The 65ft-tall granite obelisk was formally dedicated on May 30, 1924 and is modeled after the Washington Monument in our nation's capital. On the base are the names of the 578 people who died in the camp, mostly as a result of the 1918 worldwide influenza epidemic.

In the bottom section of the obelisk is a large Art Deco-style carved relief by the sculptor Robert Ingersoll Aitkin that depicts a striding "doughboy" with an eagle flying overhead.

Set into a large boulder near the base of the obelisk is a copper plaque with a relief of the Palisades, alluding to Camp Merritt's role as an embarkation point, designed and made by the local artist Katherine Lamb Tait. In the ground is a three-dimensional stone carving of the map of Camp Merritt.

The monument sits in the middle of a busy traffic circle. Visitors are urged to use caution if crossing the traffic circle to enter the monument area.

The Campbell–Christie House is a 1774 sandstone home located at Historic New Bridge Landing in River Edge. Now on the New Jersey and National Registers of Historic Places, the house was originally located in New Milford. The house was saved from demolition and moved to its current location in 1977.

In the 18th century, the house was originally built by Jacob Campbell who ran a public tavern out of it. The house was later sold to John Christie, a blacksmith, who continued as tavern-keeper.

This site also contains the County-owned historic 1888–89 Pratt-type, “pony” truss, iron swing-bridge now used by walkers and cyclists. The second stone house on site is the 18th century Demarest House.

It was moved here from New Milford in 1955 and is owned by the Blauvelt-Demarest Foundation. The third stone house is the Steuben House. It is owned by the New Jersey Division of Parks and Forestry and operates as the headquarters of the Bergen County Historical Society.



Circle of Honor War Memorial

Bergen County Court House, 10 Main Street, Hackensack

In May of 1993, the six marble slabs that make up the Circle of Honor War Memorial were dedicated at the Bergen County Courthouse in Hackensack. The memorials, set in a semicircle and overlooking a red neon eternal flame housed in granite, commemorate veterans who fought bravely in defending our nation during World War I, World War II, the Korean War, the Vietnam War, the Beirut conflict, and Operation Desert Storm.



Bergen County Remembers

Near the Circle of Honor, Bergen County and its cultural partners have installed monuments dedicated to remembering tragic events in history. The goal is to keep the memory of the victims alive so that future generations never repeat those mistakes. Circling the flagpole at the Court House are monuments to The Holocaust, Slavery, The Great Hunger, The Armenian Genocide, and The World War II Comfort Women.



Easton Tower

Red Mill Road, Route 4 & Saddle River Road, Paramus

Easton Tower is a unique rubble stone and wood frame structure along the Saddle River. It was built in 1899-1900 as the centerpiece of the ornately landscaped property of the Edward Easton estate, where it cleverly disguised the pump and water tower used to maintain the gardens. Today, it is now surrounded by busy roadways but is protected within the Saddle River Park Bikeway.

Edward D. Easton (1856-1915) is best known for his 1886 patent granted for the engraving of sound by incising wax cylinders.

Easton went on to make his fortune in the recording industry as a founder, and eventually president, of the Columbia Phonograph Company.

Easton relocated his family to Arcola in 1889, an area of modern-day Paramus, and commissioned the design of a landscaped estate.

The tower became a favorite of photographers and was also used in early silent films. This is the only structure that remains from Easton's estate.

The County acquired the tower in 1956, and most recently restored it in 2008. Easton Tower is on the New Jersey and National Registers of Historic Places.



Garretson Forge & Farm

Garretson Forge and Farm is one of the oldest sandstone houses in Bergen County and reflects over 200 years of architectural changes. The stone homestead and farm were occupied by six generations of the Garretson family, from 1720 through the middle of the 20th century.

In 1974, the homestead was threatened with demolition. In response, local citizens founded the Garretson Forge & Farm Restoration, Inc. in order to raise funds to purchase the house. This goal was realized with the assistance of the Bergen County Board Commissioners, and in 1977, the County of Bergen acquired the 1.84-acre property.

Today it is a furnished historic house museum. Garretson Forge & Farm Society's volunteers conduct house tours and special events throughout the year.

The grounds behind the house are used by the Master Gardeners of Bergen County and volunteers who grow a wide variety of specialty crops. The garden is a certified Monarch Butterfly Waystation habitat.

The County completed extensive restoration of the house and farm buildings in 2012, and again in 2023, to replace the roof and greenhouse. The house is listed on the New Jersey and National Registers of Historic Places.



Gethsemane Cemetery

Gethsemane Cemetery is located west of the Hackensack River in southwest Bergen County. The 1860 deed of sale identifies it as a “burial ground for the colored population of the Village of Hackensack.” Although few gravestones remain visible today, the burial of over 500 people have been documented, including three Civil War veterans. The cemetery’s most famous burial is that of Elizabeth Dulfer who was born enslaved c. 1790, freed in 1822, and died in 1880. During her lifetime, she became one of the wealthiest business owners and landholders in Bergen County.

Gethsemane Cemetery figured in the center of controversy after the burial of Samuel Bass. When he died on January 22, 1884, his family wanted to bury him in the Hackensack Cemetery but the request was denied due to his race. Mr. Bass was then buried in Gethsemane Cemetery. New Jersey Governor Leon Abbett protested the denial and two months later, in March 1884, New Jersey’s “Negro Burial Bill” was passed, desegregating cemeteries in New Jersey.

In 1985, Bergen County acquired the neglected cemetery and dedicated it as a County Historic Site. It was entered into the New Jersey and National Registers of Historic Places in 1994 for the historical significance it played in the enactment of N.J.’s early civil rights legislation and for containing evidence of West African burial customs.

In 2003, the county celebrated the dedication of new reflection areas and interpretive panels that tell Gethsemane’s story and list the names of over 500 people known to be buried here. More recently, a new storymap has been added to the Parks website where visitors can take a virtual tour of Gethsemane Cemetery. The cemetery is open by appointment and for special events, including the county’s annual Juneteenth Celebration.



Martin Luther King, Jr. Monument

Rev. Dr. Martin Luther King spoke at Fairleigh-Dickenson University twice. Once in October of 1966 at the old Rutherford Campus and again a year later in October of 1967 at the Teaneck Campus.

In a ceremony on October 12, 2014, members of the Bergen County Martin Luther King, Jr. Monument Committee were joined by elected officials, dignitaries, and Fairleigh Dickinson University President Sheldon Drucker for the unveiling of the Martin Luther King, Jr. statue.

The bronze statue was sculpted by acclaimed artist Richard Blake and is located on the Hackensack River Pathway as it crosses FDU's Metropolitan Campus from the Hackensack side over the river leading to the Teaneck side.



Washington Spring Garden

Van Saun County Park, Forest Avenue, Paramus

Washington Spring, located in Van Saun County Park, is associated with General George Washington and the movement of his Continental Army through Bergen County during the American Revolutionary War. On September 4, 1780, General Washington moved approximately 14,000 Continental Army troops into a strategic encampment west of the Hackensack River in modern day River Edge .

10-year-old Cornelius Banta, son of a local famer, reportedly saw Washington watering his horse at the spring, giving rise to the name “Washington Spring.” Van Saun County Park, whose 138 acres include Washington Spring, was created in 1957.



Wortendyke Barn

The Wortendyke Barn, a National Register landmark built c.1770, is an outstanding example of a “New World Dutch Barn,” an architectural structure found throughout 18th and 19th century Bergen County.

The interior structure of the barn is made completely of local wood, down to the nails. Massive tulip poplar anchor beams, supported by posts creating an H-frame, support the entire structure. New World Dutch Barns were wider than long with very steep, sloping roofs, allowing for a large storage area inside.

Side bays housed a variety of farmyard animals, and hay was stored above in a roomy hayloft. The large entrances on both gable ends allowed for the efficient unloading of the wagons. Since the floors were raised off the ground on a sill, the wood plank floors could last for decades. The Wortendyke Barn’s exhibits include handmade 18th and 19th century farm implements and tools, the history of the Wortendyke family farm, and an exhibit showing the unique construction of the barn.

The county has undertaken several restoration projects at the site over the years. In 2014, the County completed a major restoration of the barn building. A new cedar-shake roof and updated restroom were installed in the summer of 2023.

Today, the barn is used for educational and musical programming throughout the year, including the popular “Music at the Barn” concert series.

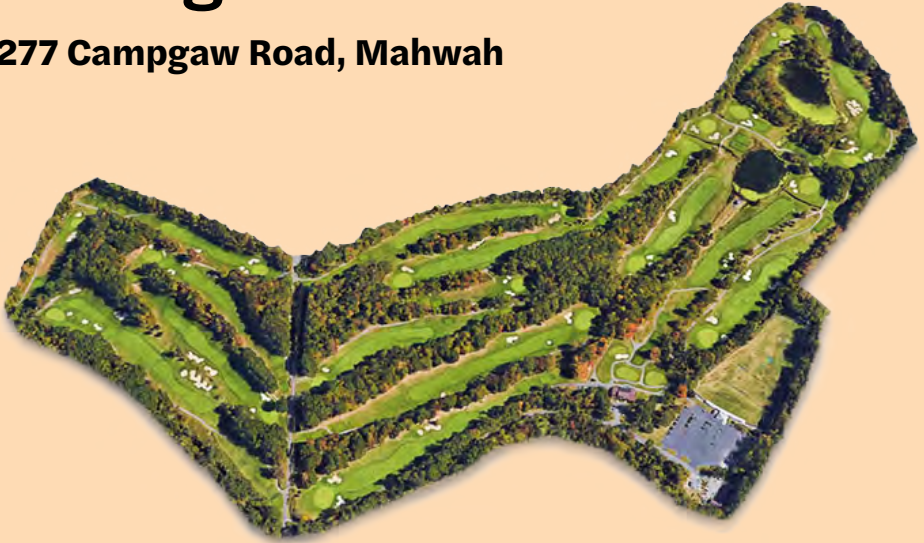

Darlington Golf Course is a 6,547-yard, par 71 in the foothills of the Ramapo Mountain Range. Tree-lined fairways and frequent changes in elevation ensure a challenging and pleasurable golf experience. The course begins and ends on the lowest part of the course. Holes #1–3 and #15–17 are on relatively flat terrain where bunkers and water hazards create the challenge. The stretch of five par 4's, beginning with #6, are routed through rolling hills where accuracy and distance control are at a premium. The long #9, at 476 yards, tests even the most accomplished golfer.

Darlington also has a 40-tee, concession-operated driving range.

Orchard Hills Golf Course is a 5,552-yard, par 70 located in central Bergen County. The course was originally designed in 1925 as the Orchard Hills Country Club. In the late 1960's, in conjunction with the development of Bergen Community College, the course was rerouted to a 9-hole track and opened to the public. The layout has a comfortable mix of short par 4s and challenging par 3s, allowing for an enjoyable round for players of all skill levels.

Overpeck

Overpeck Golf Course, a 6,584-yard, par 72, sits on 140 acres at the top of New Jersey's Meadowlands. The course is located in a natural wet setting with a number of ponds, lakes and creeks to test the most skilled golfer. The predominant water feature on the front nine is the Overpeck Creek, which presents a strong strategic element on several holes. Overpeck Creek bisects holes #5, #6, #7, and #9, challenging golfers from tee to green.

The back nine also has its share of water. Holes #13-16 circle the banks of a large lake. The 217-yard #14 and the 392-yard #15 can be monsters if the wind is blowing out of the south. The course finishes with a short par 3 designed to end the round on a high note.

Rockleigh

Rockleigh Golf Course, a 6,584-yard, par 72, offers a scenic round of golf with rolling hills and strategic bunkers. The course is the County's only 27-hole facility and plays as two distinct courses, featuring a variety of holes to challenge golfers of all skill levels. The front nine starts easy with two short par 4s, but quickly ramps up with a challenging par 3 over water. The back nine includes uphill battles and strategic water hazards. The additional nine holes are perfect for beginner golfers looking to hone their skills.

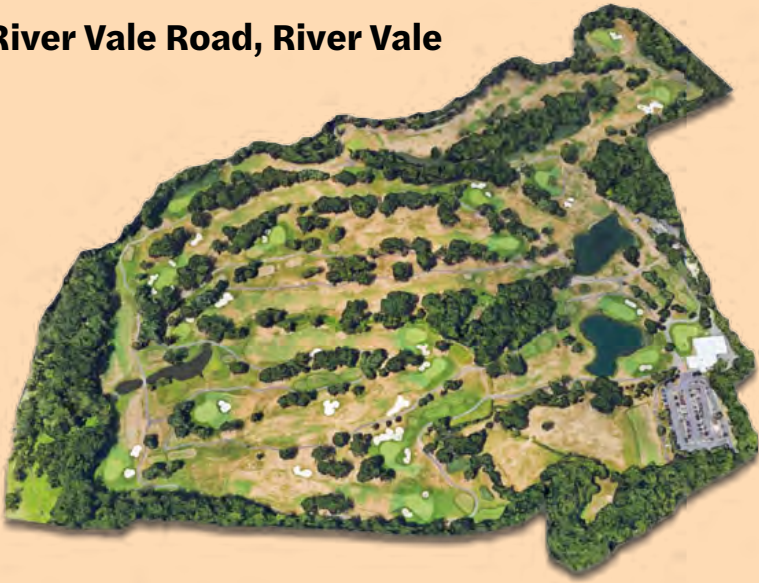
Soldier Hill Golf Course in Emerson is a 6,949-yard, par 71 and offers superior playing conditions. Many of the picturesque holes demand accurate shot-making from tee to green while others offer ample landing areas and gentle sloping greens. The back nine winds through open terrain with strategic water hazards while the front nine is characterized by mature tree lined fairways. The layout of open and wooded holes provides challenges to golfers of all skill levels.

Valley Brook Golf Club is a 6,211-yard, par 70, offering scenic and challenging round designed by Bill Boswell. Renovated in 2001 and again in 2014, the course winds along the banks of Pascack Brook, providing a unique experience for residents. Rolling terrain and strategic landscaping create a classic layout that tests golfers of all skill levels.

The Pioneer Tour

Created in 1995, the Pioneer Tour was developed to provide beginners with a sound foundation in both golf mechanics and golf etiquette.

In a county where tee times are at a premium, it is often difficult for young golfers to find a place to play. The Clinic, Q-Tour, and Pioneer Tour introduce young golfers to the game and provide opportunity for play. Over eight hundred kids participate in the program every year.

AllPar Golf Program

The AllPar Program brings the enjoyment of golf to youth with special needs. The program teaches an introduction to the game, emphasizing basic information and instruction. The fundamentals are presented by the instructors and reinforced by teaching assistants in both a classroom setting and on the practice tee. The use of Snag golf equipment, large-face plastic clubs and tennis balls, provides the first step in the learning process. The instructors present the grip and stance for a putting stroke and then students practice these concepts on the practice tee.

Targets placed a short distance from the golfer are used to convey the importance of distance control and alignment. Once these skills have had a chance to sink in, chipping is introduced. The full swing is only discussed after the development of the shorter swings of putting and chipping.

Exposure to the different areas of the golf course increase the interest of the players. The practice tee and green serve as home base for the program. A walk through a few holes and the setup of a short course, either on the practice range or the course, help with the enjoyment of the activity.

The lesson plan provides a path of instruction. The talking points are shared with the participants in the meeting area before they proceed to the practice tee.

The pace of the program depends on the development of the individual participant. Entire families are encouraged to participate so the interest created at the program continues during family recreational opportunities.

The Bergen Equestrian Center, is a multi-service horse facility on 22 acres of landscaped grounds providing a home for over 75 horses.

Amenities include three outdoor riding rings, two indoor riding rings, air-conditioned tack rooms, and a heated lounge with a panoramic view of the main indoor arena for an optimum year-round experience.

Programs include children’s camp, group and individual riding lessons, corporate team building, and A Stable Life— a non-riding equine treatment program focused on prevention, education, healing, and assisted recovery for those dealing with life challenges like anxiety, isolation, loss, addiction, or symptoms of PTSD.

The Bergen Equestrian Center is also home to Columbia University’s “Man O’ War Project,” which aims at providing equine therapy to veterans suffering from PTSD.
